POLICY TOPIC DESCRIPTION

SUNDAY AND WEDNESDAY AFTER SCHOOL ACTIVITIES POLICY

POLICY STATEMENT

Except as otherwise prohibited by the Kentucky High School Athletic Association, all Pikeville High School after school activities (i.e., sports, band, chorus, club and organizations), which are conducted after normal school hours, shall not be conducted on Sundays except during the hours of 1:00PM to 5:00PM. The coach or sponsor of the activity must receive prior approval from the school principal and the school superintendent before conducting such activities.

So to provide additional scholastic and family time, as well as adequate rest, after school hours activities should be avoided after 6:00PM on Wednesdays, if practical, but will be permitted if the coach or sponsor's request is approved by the school principal when reasonably necessary due to lack of access to or availability of facilities at other times. It is the school's policy to require all coaches or sponsors of these activities (normally conducted during non-school hours) to exhaust all other available practice and meeting times and to work with other coaches or sponsors to do so before convening on Wednesdays after 6:00PM.

Any coach who conducts an activity after 6:00PM on Wednesday or on Sunday without prior approval will be suspended one game for the first violation. Subsequent violations will result in multiple game suspensions.
